LU is a resident-driven organization and we hope that you will join us to discuss those important issues facing our community now and how we can all work together to address them. At this meeting, we will be collecting membership dues for those of you who need to renew for 2015, and we will also begin our Board Member election process and hope that you will participate by voting.

Election Information for the 2015-2017 Term for LU Board of Directors:

- LU issued an open call for interested members who were interested in serving on the Board of Directors. Those interested members appear on the ballot below.
- All current general members of Lawrenceville United who are at least 18 years old are permitted to vote in this election. 2015 dues must be paid in order to be considered a "current" general member.
- If you have not renewed your membership this year, simply bring the completed renewal form on the other side with membership dues to the General Membership and you will be eligible to vote.
- You have 3 opportunities to vote:
- You can complete your ballot at the General Membership Meeting.
- You can complete this ballot and drop it off or mail it to Lawrenceville United by June 30th.
- You can complete the google form ballot on our website: www.lunited.org.

Lawrenceville United Election Procedure:

- The LU Board of Directors consists of 10-13 members.
- The By-laws of LU permit the election of 4-7 board members every "even year". These 4-7 members are elected as at-large representatives, which is different than our "odd year," elections when 2 board seats are elected from the 6th Ward, 2 residents elected from the 9th Ward and 2 residents elected from the 10th Ward.
- Current Board Members and new nominees are included on the ballot below.
- **Please vote for no more than 8 total candidates as we have 8 seats being filled through this election.**
